**Family Membership documentation requirements: (If last names differ, additional documentation is required.)

- ▼ For children with differing last names, proof of dependency is required. Some examples include a birth certificate, medical card, medical insurance statements, adoption/foster/guardianship paperwork.
- ▼ For adults with differing last names, proof of same residing address is required. Examples include cell phone bills, utility bills, voter card, paycheck stubs, credit card statements, car and mortgage notes. Please note that addresses must match for both adults to be on the same membership.

OPEN DOOR MEMBERSHIP (INCOME-BASED RATES)

GUIDELINES

- ▼ Open Door is offered for Adult and Family membership categories only
- ▼ Calculated on Household Gross Annual Income, regardless of membership category or who is on membership
- ▼ Renews annually and requires updated financial information at renewal

To qualify, the following proof of income is required:

- * Federal tax form 1040 w/W2's
- * Two most recent consecutive pay stubs
- * Unemployment Gross Weekly Benefit
- * Statement
- * Social Security Monthly Benefit Amount
- * Disability Monthly Benefit Amount
- * Retirement/Pension Monthly Statement
- * SNAP Monthly Benefits (formerly food stamps)
- * LIHEAP Annual Energy Assistance
- * Child Support Weekly Benefit Amount
- * WIC Benefits
- * Rent/Housing Subsidy
- * CCR&R Benefits

Please complete a "Request for Open Door Membership" form available at the Welcome Center or on our website at <http://www.k3ymca.org/membership/financial-assistance>. Requests are processed by the Membership Review Committee. You will be contacted once review process is complete and eligibility has been determined. If information is withheld from the Membership Review Committee, a disqualification of the open door program may result for a 6 month period.
