Our YMCA's vision is to strengthen the foundation of Kankakee County by increasing the number of healthy families. We achieve this goal by nurturing the growth and development of every child and teen we serve, improving our communities' health and well-being, and giving our friends and neighbors an opportunity to give back to the community they love.

We enjoyed a highly successful 2012. Some highlights include:

#### **CHARLTON KIDS' FIT ZONE:**

As part of the Y's commitment to strengthen community by addressing critical gaps in healthy living and the rising growth in childhood obesity, the Charlton Kids' Fit Zone offers children ages 3 to 15 the ability to be active while their parents work out at the Y. Thanks to the support from the Charlton Family Charitable Foundation, children in Kankakee County now have access to an innovative state-of-the-art fitness venue, making possible the Y's vision of building fit kids a reality.

#### PIONEERING HEALTHIER COMMUNITIES:

In May of 2012, this initiative sponsored the Live Healthy Summit to address the critical issue of reducing childhood obesity by promoting a more active lifestyle. Community leaders attended a three-day summit given by nationallyknown fitness expert Mark Fenton. This summit focused on the design and implementation strategies that encourage residents to be more active by walking and bicycling more frequently. One key result from the summit was the City of Kankakee leading the charge by adopting the Complete Streets Program as an ordinance and plan to develop a healthier community. Plans for the communities of Bourbonnais and Bradley have been developed and we look forward to their implementation.

#### **FINANCIAL ASSISTANCE:**

Provided approximately \$218,000 in financial assistance. Thanks to a record 2012 Strong Kids Campaign, thousands of area kids and families were able to afford membership and program fees.

#### **RENOVATIONS:**

We continue to reinvest in the facility in order to make your Y experience even better.

• **Gym Floor:** After three months and over \$40,000, the gym floor was renovated by the company 90% of the NBA teams rely on. This beautifully restored area provides a great platform for area youth to have fun and to learn skills and values that last a lifetime.

#### • New Pool Ultraviolet (UV) System Installed:

Our new UV systems provide the cleanest, safest and most comfortable pools in the area!

- **Pool Scoreboard and Bleachers:** Thanks to generous donations, the Y Stingrays Swim Team is now able to hold regional competitions.
- Wi-Fi: Your favorite Y activities now come with complimentary Wi-Fi. Get some work done, check email, and connect with friends...for free!

# HEALTHY LIVING CHARLTON KIDS FIT ZONE



As part of the Y's commitment to strengthen community by addressing critical gaps in healthy living and the rising growth in childhood obesity, the Charlton Kids' Fit Zone offers children ages 3 to 15 the ability to be active while their parents work out at the Y. It is also used by other programs such as preschool, camp, and school age child care to offer fitness alternatives.

The Charlton Kids' Fit Zone consists of four LED televisions with Xbox 360 Kinect. The controller-free gaming means full body play for kids.

#### JERRY BLITZ AWARD

Example, Loyalty, Enthusiasm, Sharing, Determination

If ever there was a friend of this organization, it was Jerry Blitz. In his short time on this earth, Jerry taught everyone how to live, laugh, and even die with effervescence. He enjoyed every day to its fullest and gave his time tirelessly, often without being asked.

Jerry was known for his honesty and for his wisdom. He was revered for taking projects by the horns and plowing full speed ahead. He often said, "Don't just sit there and talk about doing something. Either do it or don't do it."

The Jerry Blitz Layman of the Year Award is the highest "thank you" that the Kankakee Area YMCA can give to an individual. Award winners are selected and judged on 5 criteria: Example, Loyalty, Enthusiasm, Sharing, and Determination. These five qualities capture the essence of Jerry; his wisdom, his teaching, and his spirit.

Upon joining the Board of Directors in late 2006, Paula Jacobi jumped immediately into the work of the Y. The depth and breadth of her involvement was impressive. What will be remembered are the many accomplishments during her tenure as the Board of Directors Chair (2008-2011). Most notable is her focus on moving the organization forward strategically. That is evident by the 2012 Strategic Plan and the alignment of all efforts to this plan. The fruits of this focus can be seen in the growth of the organization and the lives impacted by this Y.

Although Paula's term expired as the board chair, she continues to volunteer at a high level. She accepted the leadership of the 2012 Strong Kids Campaign. The campaign had a goal to raise \$80,000. Indicative of her personality, the goal was too low. She believes that by exceeding the goal, more kids would have a chance to participate in the Y. The campaign raised more than \$94,000. Paula's determination ensured more kids in Kankakee County will have that chance!

Paula Jacobi definitely represents the award's criteria of Example, Loyalty, Enthusiasm, Sharing, and Determination. She is an extraordinary volunteer and representative of the mission of the Kankakee Area YMCA.

## RAY LINDNER SERVICE TO YOUTH AWARD

Kankakee Y Service Club Hall of Fame

#### KAY GREEN



The Ray Lindner Service to Youth Award is given annually by the Area Y Service Club. It singles out an individual in our community who leads by example and devotes themselves when possible to further youth quality of life. Ray Lindner was such a man.

This award is meant to serve as an example and not a memorial. The Y Service Club, an International Service Club of the Y hopes you will feel challenged and inspired by the recipient and the award.

This year's award winner, Kay Green, is a life-long resident of our community. An early commitment to youth inspired a bachelor's degree from Illinois State University, Masters from the University of Illinois and Doctorate from Illinois State.

Her first youth service began as a supervisor at Kankakee's Washington Park and then as an English teacher for three years in Manteno. That followed with a long and productive career at Kankakee School District 111.

Kay volunteered through many organizations and rose to the top leadership role in most of them presiding over the Kankakee Kiwanis's Club, Provena St. Mary's Foundation, the Community Arts Council, Kankakee County Historical Society, Kankakee Valley Symphony (twice), Kankakee County United Way Campaign, Junior League and American Association of University Women. While serving as President of those organizations she initiated many projects with an emphasis on youth.

Kay is a past YMCA Board of Director member and currently a YMCA Board of Trustee member. When the Kankakee Area YMCA was chosen as one of sixteen Y's from Illinois, Michigan and Ohio to help build critical statewide networks that target childhood obesity, it is no wonder that the Y asked Kay Green to head this project, Pioneering Healthier Communities. She immediately accepted and quickly put together a strong coalition after a training session in Washington D.C. Addressing childhood obesity will be perhaps the most challenging volunteer project Kay has ever undertaken. There is, however, no one better prepared to do it.

Thank you Kay for all your service to the youth in Kankakee County. You are an extraordinary volunteer and a very deserving recipient of the 2012 Ray Lindner Service to Youth Award.


